Purpose

Scope

This policy applies to all operations, from management to the executive level of our company. Staff, suppliers, and partners are expected to fully uphold objectives under this policy whenever possible within prevailing budgets.

We acknowledge we have limited influence over third parties. While we cannot control the decisions of these parties, we commit to educate them of our policy and encourage them to align operating practices with policy objectives.

Sustainability commitment

We will use the Travelife platform to report on our sustainability progress and to monitor and evaluate progress. We are committed to (publicly) communicating our sustainability performance (by means of the Travelife report) every two years.

Internal management: environment

Environmental management of office operations

We are committed to keeping the direct footprint of our business operations as minimal as possible and actively follow circularity/the 5Rs (refuse, reduce, reuse, repurpose, recycle)/sustainability/environmentally- sound principles. We have the following measures in place:

- Follow all local and national regulations concerning environmental law
- Procure office supply locally, seasonally, fair trade, in bulk, with limited packaging, sustainability certified whenever possible
- Print only when absolutely necessary, and when printing, always print double-sided on grayscale. Energy-saving measures are in place in all common areas
- All equipment and lighting is energy-efficient and turned off/unplugged/on sleep mode when not in
 use
- Water-saving measures will be in place in all common areas and restrooms, including water capture in external areas
- Waste is separated into the following categories: plastic, paper products, metal, glass, waste to landfill and is disposed of properly by the municipality
- Noise, light, and air pollution is minimised

Carbon management of office operations

"Somewhere We Know" is committed to reducing our carbon footprint and endeavours to:

- Reduce the amount we travel as much as possible
- Encourage remote work whenever possible, and when it is not possible, make it easier for employees to limit their carbon footprint by use of eco modes of transportation.
- Installing energy-efficient equipment and appliances where appropriate/possiblee

Energy Reduction Policy

"Somewhere We Know" commits to actively contributing to the reduction of global warming, especially focusing on the reduction of electricity & energy consumption. The following actions have been introduced;

- 1, When entering the company, only the necessary blocks are turned on, and the last person leaving the block always turns off the corresponding block when leaving the office.
- 2, Be sure to turn off the lights, projectors, displays, etc. in unused conference rooms.
- 3, Set the temperature of air conditioning (cooling, heating) appropriately. (Do not lower or raise the temperature too much).
- 4, Turn off the power of the PC & Printer display outside the usage time. 5, Set the electrical equipment to energy-saving mode as much as possible. 6, We actively reduce the use of disposable and consumer goods. 7, We encourage the purchasing of green energy and energy-efficient lighting equipment for all areas (if resources and budget approve).
- 8, Preferences towards low-energy equipment when buying new items, including considerations of cost and quality are in place.
- 9, We comply with the national legislation concerning waste disposal.
- 10, We encourage employees to use public transport or sustainable means of transport.

Land use

"Somewhere We Know" offices are located in an urban area and we abide by all local land use laws, respect local cultural and natural resources in our business operations, and favour sustainable architecture and design.

General suppliers policy

"Somewhere We Know" is committed to sourcing its products and services responsibly, avoiding harmful impacts on society, culture and nature as much as possible. We expect the same level of engagement and commitment from our suppliers.

"Somewhere We Know" prefers to work with partners that share the company's commitment towards sustainability. This means that we prefer partners that have a written sustainability statement as an integral part of their business policy and/or a clear sustainability policy in place.

"Somewhere We Know" prefers to work with suppliers in the destinations that are locally owned or managed, use local and seasonal products and services and benefit the local community by hiring locally and equitably and by providing fair working conditions.

"Somewhere We Know" expects its suppliers to adhere to a Code of Conduct, that includes the following responsible business practices:

- Respecting all human rights including labour rights, children's rights, and women's rights
- Committing to fair employment conditions
- Following anti-corruption, anti-bribery, anti-extortion, and anti-discrimination policies
- Protecting children from (sexual) exploitation through tourism
- Protecting the environment and natural resources
- Acting in the best interest of local communities

Inbound partner agencies

In the entire process of developing and operating its travel packages, "Somewhere We Know" expects partner agencies to act in the best interests of the surrounding communities and environment as well as its guests.

One of "Somewhere We Know" methods to select a supplier is if they engage in socially responsible actions and promote an ethical treatment of their employees.

Transport

When selecting transport for guests and business related travel, "Somewhere We Know" commits to choosing the most environmentally friendly options available for travelling to, from, and within the destination – taking into consideration distance, price, route, and comfort.

"Somewhere We Know" will implement clear guidelines for reducing GHG emissions from transport and selecting the most environmentally friendly transport options, including the following measures:

- Preferring ground transport over air transport for short-haul travel destinations
- Avoiding in-destination flights as much as possible
- Using public transportation options in the destinations
- Using appropriate vehicle sizes for group sizes
- Training drivers on eco-driving techniques

Accommodations

In the accommodation selection process, "Somewhere We Know" considers the sustainability practices of an accommodation by taking into account their sustainability management and social and environmental footprint.

"Somewhere We Know" favours the selection of accommodations that respect and protect land use, as well as respectfully highlight elements of local architecture, customs and traditions

Activities & Excursions

All excursions and activities run by or on behalf of "Somewhere We Know" respect local customs, traditions, cultural integrity, and natural resources.

"Somewhere We Know" commits to not offering any excursions that harm humans, wildlife, environment, or natural resources such as water and energy.

"Somewhere We Know" gives preference to excursions and activities that benefit local communities, respect animal welfare and support environmental protection.

Child Abuse and Exploitation

"Somewhere We Know" recognizes that the commercial, sexual or any other form of exploitation and harassment of children is a world-wide problem and should be addressed by all companies in the travel industry.

In all our activities, travel experiences and operations we actively disagree with all kinds of exploitation of children and do not collaborate with companies that exploit children through child labor or other forms of abuse.

Tour leaders, local representatives, and guides

"Somewhere We Know" provides guides with learning opportunities on sustainability topics including providing free access to the Travelife online learning platform.

Destinations

Sustainable destinations

"Somewhere We Know" prefers to work in destinations that have committed to sustainability as an integral part of community and destination development.

"Somewhere We Know" aims to send visitors to secondary or lesser-known tourist areas to avoid overtourism.

"Somewhere We Know" does not support destinations that have a questionable human rights track record.

Contribution to local communities / local economic network

"Somewhere We Know" commits to positive contribution to the destinations in which we operate, by:

Sourcing locally and responsibly, and supporting local and traditional arts and culture

- Not allowing the purchase of souvenirs containing threatened flora and fauna species, any illegally obtained historic/archaeological artefacts, drugs or illegal substances, and abide by local and international laws in place to prevent this.
- Encouraging guests to shop responsibly and educating them about illegal/prohibited/forbidden souvenirs
- Collaborating with other local tourism stakeholders (including local government, other tourism businesses, academia, and community groups) to further the sustainable tourism development of the destination
- Respecting and advocating for all human rights (i.e. children's rights, women's rights, labour rights, etc.) as well as land rightsis.
